## **Background**

# Establishment of a Trust fund for Aboriginal cultural fishing

At the last meeting the Council requested that a Trust Fund be established to ensure the AFAC is appropriately funded. The funding would allow AFAC to gain external advice, if necessary, to ensure its decisions are appropriately informed. The trust could also be used to fund Aboriginal cultural fishing initiatives. An update on this request will be provided at the meeting.

## Remuneration arrangements for NSW public servants on the AFAC

Several AFAC members are employed by other NSW Government departments. In accordance with NSW Government policy, NSW public servants can not be paid sitting fees for their attendance at Council meetings unless an exemption is approved by the Premier. However, at the last meeting, it was brought to the attention of the Council that several AFAC members had taken Recreational Leave to attend the meetings, and were therefore disadvantaged.

At the request of the Council, NSW DPI has written to each of the respective employers to enquire about leave arrangements of the public sector employees on AFAC, and whether or not an exemption should be sought.

Acting on advice from the Government employers, an exemption is currently being sought for those public sector employees who are required to take leave from work to attend AFAC meetings. For those AFAC members who have been able to make arrangements with their employers to attend AFAC meetings as a normal paid working day, an exemption has not been sought.

## **Executive Officer position**

At the request of the Council, a position description (PD) for an Aboriginal Executive Officer for AFAC was drafted by NSW DPI in consultation with AFAC members; Stephan Schnierer, Natalie Rotumah, and Joe Flick. A final version of the PD was forwarded to the whole Council on 13/4/11 for review. No comments were received.

The Council will be updated on the current status of this request for a position at the meeting.

#### Promotion of the Council

At the request of the Council, NSW DPI is currently seeking approval to include an Aboriginal fishing page on the NSW DPI website. It is also proposed to include a section on the webpage that explains the role of AFAC and provides some background on each of the AFAC members.

Consultation with each AFAC member has been undertaken out of session to seek their consent to display the following details on the website:

- AFAC member names, and their position on the Council,
- a short personal profile on each member, and
- a photograph.

The Council will be updated on the outcomes of this consultation process and the progress of establishing an Aboriginal fishing webpage at the meeting. The Council may also wish to discuss other ways of promoting the Council.

## Exchange of AFAC members email addresses

At the request of the Council, NSW DPI has attempted to contact those AFAC members who did not attend the last meeting, to seek their approval to exchange their email addresses with the rest of the Council. Responses from several Council Members are still pending.

#### Habitat restoration programs

Cultural fishing regulations and outcomes from the Regulations Working Group

# **Background**

The Regulation Working Group (RWG) was formed to progress the development of cultural fishing regulations that are required to enact Section 21AA of the *Fisheries Management Act 1994*.

The RWG met on 7/6/11 and recommended that the regulations be developed in a two stage process. A Summary Paper was distributed to the full Council on 12/7/11 to inform AFAC of the outcomes from the RWG meeting and to seek feedback on the working group's recommendation on a way forward.

No dissenting feedback was received, so it is assumed that the working group's recommendation is supported by the full AFAC.

As such, it is proposed to pursue the immediate amendment of the *Fisheries Management* (*General*) Regulation 2010 to include an altered version of the ICP. This will require broader consultation on the working group's suggestions for inclusion in the regulation with the Department's legal, compliance and management sections and further discussions with the AFAC on drafts of the regulation.

Broader community consultation on any proposed actions or changes is also required. A process for undertaking this consultation requires further consideration by the Council.

Draft Fisheries Management Orders for the Lowland Darling and Lachlan River Catchments

AGENDA - AFAC Meeting 2 - Wollstonecraft, 19 & 20 September 2011

## **Background**

The Minister for Primary Industries is seeking AFAC's advice on two draft Fisheries Management Orders, including the:

- Draft Fisheries Management (Fishing Activities in Lowland Darling River Catchment ) Order 2011; and the
- Draft Fisheries Management (Fishing Activities in Lowland Lachlan River Catchment ) Order 2011.

The lowland catchments of the Darling River and Lachlan Rivers are listed as Endangered Ecological Communities under the *Fisheries Management Act 1994.* (the Act). The Act enables the Minister to make an Order authorising a class of persons to carry out an activity that may result in harm to a threatened species, population or ecological community or damage to its habitat. The object of the attached Orders is to allow certain recreational and commercial fishing activities to occur in the areas, subject to compliance with any applicable fishing regulatory controls imposed by or under the Act.

Species Impact Statements (SISs) have been undertaken for each of the proposed Orders, and will have been provided to the Council prior to the meeting. The Council will be provided with an overview on the draft Orders and SIS's at the meeting.

#### **Background**

Associate Professor Stephan Schnierer, Southern Cross University, will provide an update on Indigenous Fisheries Research, including:

- Indigenous Cultural fisheries in the Tweed region (FRDC funded),
- Research on Indigenous commercial fishing in NSW (FRDC),
- New application to FRDC to look at Indigenous fisheries governance (pilot study, Tweed Heads),
- FRDC's National Indigenous Reference Group and Cairns workshop update, and
- The FRDC Indigenous fisheries scholarship.

## Agenda item 9

#### Issue

Cultural and fishing workshops

## **Background**

A number of Fishing and Cultural workshops for Aboriginal children are undertaken each year as part of a state-wide program run by NSW DPI and supported by funds from the NSW Recreational Fishing Trust.

These workshops are undertaken in partnership with Aboriginal groups/organisations and educators, and are free to each participant.

The workshops not only offer Aboriginal children fishing skills, they also teach them social interaction skills and provide a great opportunity for the parents, grandparents, aunties and uncles to share their knowledge.

Children receive a rod, reel, hat, tackle box, educational material and a Certificate of Achievement recognising the knowledge and experience they have gained on fishing and Aboriginal culture.

The activities include a guided fishing session and talks on:

- rules and regulations
- fishing safety
- conservation of fish habitats
- cleaning your catch
- knot tying
- line rigging and baiting
- casting techniques and retrieval of fish
- Aboriginal culture

Workshops are for school children (minimum age 8). A workshop will generally last no more than 6 hours and the maximum number of participants is 25.

Agenda item 10 AFAC Members

#### Issue

AFAC procedures to be developed

#### **Background**

At the inaugural meeting, the Council identified a number of procedures that need to be developed in order to assist the Council with its role and function, including:

## Process for reviewing funding requests related to Aboriginal fishing

At the last meeting, the Recreational Fishing Saltwater Trust Expenditure Committee (RFSTEC) referred several community trust application from Aboriginal organisations to AFAC for review. The Council was reluctant to provide advice on these applications before first establishing procedures and criteria for reviewing such applications.

As such, further discussion is still required on this matter. A suggested approach is provided below:

# 1. Establish criteria to assess the application

Example criteria could include:

- Can any AFAC members verify the legitimacy of the group making the application?
- Is AFAC aware of any other similar projects?
- Can AFAC see a need for the project?
- Can AFAC foresee any problems with the project?

# 3. AFAC to vote on support/dissent for the project

Once the application is assessed against the criteria in 1(above), Council to vote on whether or not the project should be supported by AFAC. A majority vote will determine the outcome.

Note. The final recommendation regarding trust funding expenditure is made by the Advisory Council on Recreational Fishing (ACoRF), although any advice from AFAC will be useful to ACoRF in making their decision.

Recommendations from RFSTEC regarding the Aboriginal fishing projects that were referred to AFAC for advice in March are provided in Appendix B for the Council's information. These recommendations were made at the RFSTEC meeting held on 5 & 6 April 2011.

## Procedure for reviewing fisheries management proposals

The Council identified the need to establish a process for reviewing any fisheries management proposals that are relevant to Aboriginal cultural fishing. Examples of such reviews include the annual review of the Total Allowable Commercial Catch for the abalone and lobster commercial fisheries, and the 2011 review of Recreational Fishing Rules.

Further discussion is still required on this matter, however a suggested procedure for reviewing fisheries management proposals is provided below:

- 1. All AFAC members to review the proposal and provide feedback to Chairperson or Deputy Chairperson.
- 2. Chairperson or Deputy Chairperson to collate feedback.
- 3. Collated feedback to be endorsed by full AFAC (either Out of Session or at next meeting) before then being submitted.

# <u>Process for AFAC members to be nominated to represent AFAC at fisheries related workshops, forums and meetings</u>

The Council recognises that AFAC representation may be required at other fisheries related workshops, forums, advisory meetings etc. Consequently, it is considered necessary that a process for nominating members to attend such workshops, forums etc be established.

A suggested procedure that will ensure a fair distribution of the Council's workload amongst its members is provided below:

- 1. First establish if there are any AFAC members who would like attend.
  - Yes they are nominated. No go to 2.
- 2. Are there any AFAC members with knowledge of the topic, or from the relevant area? Yes they are nominated. No go to 3.
- 3. Are there any AFAC members who have not yet represented AFAC on any external meetings/workshops?

Yes – they are nominated. No – go to 4.

Obviously there may be times when the person nominated is unable to attend due to work, family or other commitments. In such cases, if an alternate member is unable to attend, the Council's apologies will be given.

It is important to note that whoever is nominated to attend, will be required to provide feedback to AFAC either OOS or at the next AFAC meeting.

#### Process to ensure Aboriginal representation on fisheries Councils & Committees

Currently, there are vacancies for Aboriginal representatives on the Advisory Council for Recreational Fishing (ACoRF) and each of the commercial fishery Management Advisory Committees (MACs). When this was brought to the Council's attention at the last meeting, the Council considered it a priority to ensure that Aboriginal representation is secured and maintained on all of the NSW fisheries Councils & Committees.

To progress this, consideration on how to identify and locate suitable people to be nominated for these advisory bodies is required, as well as identification of the current issues associated with retaining Aboriginal representatives on these advisory bodies.

Note. A list of all the fisheries Councils & Committees and the status of any Aboriginal positions on these Councils/Committees will be provided at the meeting.

Commercial fisheries management update

## **Background**

An update on commercial fisheries management, including the independent review of commercial fishing arrangements in NSW, and the fishing closure review will be provided.

## Independent review of commercial fishing arrangements in NSW

Following up on its election commitment, the NSW Government is committed to undertake a review of commercial fishing arrangements in NSW.

The independent review will look at NSW fisheries policy, management and administration to identify strategies that will enhance the long-term economic viability of the commercial industry and ongoing sustainability of the resource.

## Fishing closure review

Fishing closures under the *Fisheries Management Act 1994* have been implemented for a number of historical reasons. As part of the Government's reform program for NSW commercial fishing, the Department is working with all stakeholders to review current fishing closures, except Recreational Fishing Havens and Marine Park Zoning, for their relevance to industry, the resource and the community.

Consultation with the commercial industry was undertaken in March 2010, to gain feedback on what closures industry consider in need of review.

Industry was also invited to comment on the draft principles (below), that will be used to assist NSW DPI with determining if the changes to fishing closures or area restrictions suggested by industry should be pursued:

**Principle:** Changes to fishing closures/area restrictions should not result in *unacceptable*:

- adverse impacts on important fish habitat;
- ▶ increased interactions with threatened, protected or endangered species;
- direct or indirect unsustainable impacts on fish stocks:
- ▶ high levels of conflict between commercial fishers and other stakeholder groups.

#### Issue

Pipi management and research

## **Background**

The NSW Government is aware that there has been a decline in the abundance of pipis on NSW beaches, including those commercially harvested and those that are not harvested.

In response, an industry-initiated minimum commercial size limit for pipis of 40 mm has been in place since June 1. A new commercial limit is also now in place preventing the taking of more than 40 kg pipis in a fishing session.

A planning group which includes aboriginal, commercial, recreational and conservation stakeholders has been formed to advise on medium and long term research and management to ensure sustainability of the pipi resource.

The short term management of the resource will include partial closure of the fishery and collaborative research on pipi stocks led by Departmental scientists in collaboration with commercial and recreational fishers.

The NSW Department of Primary Industries is committed to maintaining a sustainable commercial fishing industry that supplies the public with fresh local seafood, whilst conserving fish stocks and habitats.

An update on pipi management and research, including any outcomes from the first meeting of the pipi resource planning group, will be provided at the meeting.
