Issue

Cross Cultural Awareness Training

Issue

Fish Aggregation Buoys - program overview

Background (NSW Fisheries)

Fish attraction buoys have been installed along the NSW coast under a \$230,000 project funded by the NSW recreational fishing licence. The buoys, to be trialed over two years, have been installed at 10 sites along the coast with the aid of charter fishing operators and local recreational fishing clubs, to provide better fishing for recreational sport and game anglers. The trial will include surveys to monitor what species anglers are catching near the devices.

Fish attraction buoys are well known around the world to assist in attracting various pelagic fish species including tuna, dolphin fish, kingfish and billfish. These surface dwelling fish are drawn to the structure of the buoy and the mooring rope, which they use as a reference point in clear ocean water.

Fish attraction buoys have been installed at Byron Bay, Coffs Harbour, Port Stephens, Forster, Terrigal, Jervis Bay, Narooma, Batemans Bay, South West Rocks and Sydney. Because the buoys attract large quantities of fish during the summer months, they'll be installed for the summer fishing season and serviced during the winter months to ensure longevity.

The location of the fish attraction buoy may fluctuate slightly depending on wind, swell and current direction. The buoys are not designed as mooring devices - tying off to the buoy may cause the anchor to drag or the buoy to break free. Fines of up to \$5500 apply.

An overview of the program will be provided at the meeting.

Outcomes

An update of the program was given detailing the deployment of the ten buoys, their locations and success of the program to date.

A decision was made not to exclude commercial fishers from using the FADs, as their exclusion could cause further animosity between recreational and commercial fishers. It was explained that commercial fishers were consulted prior to the deployment of all ten buoys to limit the possibility of the buoys being placed in areas where they may impact upon commercial fishing practices. To date there has not been any documented case of conflict between commercial and recreational fishers in relation to the FADs.

The committee discussed the impact of FADs on dolphin fish (mahi mahi), in particular the lack of bag and size limits for the species. It was confirmed that dolphin fish do have a bag limit of 20 per person per day, however no legal size limit currently exists. The introduction of a size limit and a reduction in the bag limit was suggested. Size and bag limits for dolphin fish, as well as other species, will be addressed in the Recreational FMS. Spearfishing clubs will be included in the FMS consultation.

Safety concerns were raised regarding excessive use of the FADs, such as the increased possibility of an accident (for example, a collision between vessels). It was highlighted that no such incidents had been reported to date. Further, the Manly Hydraulics waverider buoys have been used as FADs by anglers for a number of years without major incident, which led to the introduction of a regulation allowing the use of waverider buoys as fishing grounds.

Issues regarding the design of the radar reflector and the cost of the program were raised. The design of the radar reflector will be reviewed, to limit its use for mooring purposes and increase its effectiveness. The full cost of the program was explained, emphasising that funding for the program covers the salary of the program coordinator, travel, consumables, printing (logbooks, envelopes etc) and marine running costs, in addition to the purchase of the actual buoys. The council expressed considerable support for this program, however, it was noted that some information appearing in the media regarding costs is not correct. It was suggested that NSW Fisheries clarify the cost of the buoys and the overall program in media releases etc.

The annual removal of the FADs was raised with concern expressed regarding the loss of growth on the structure and rope, hence loss of effectiveness of the buoys. It was explained that to limit the loss of the buoys, they would be removed annually and replaced with a new buoy. This process will be completed through the winter months when the buoys are not regularly fished, giving time for the mooring lines and buoys to attract significant growth by the following summer fishing season.

It was explained to the council that a number of fishing clubs and charter operators were instrumental in the initial selection of sites and the deployment of the FADs. One member stated that he had gained very positive feedback from a charter boat operator from the South West Rocks area regarding the success of their local FAD.

Issue

Recommendations from the 9th Recreational Fishing Saltwater Trust Expenditure Committee meeting regarding expenditure from the Saltwater Trust.

Background (NSW Fisheries)

With a view to assisting consultative arrangements with recreational fishers and to increase transparency in the trust fund application process, an invitation to the community to submit proposals for funding from the Recreational Fishing Trusts was advertised in March 2003. NSW Fisheries conducted an extensive advertising campaign across a wide variety of mediums to promote the expression of interest process. A press release was forwarded to media agents throughout NSW, including radio, newspapers and magazines, and the advertisement was subsequently aired on a number of radio stations.

The expression of interest invited applications for programs to be funded from the freshwater and saltwater trusts. The expression of interest advised that proposals must enhance recreational fishing and would receive priority where: the benefits to geographic areas or numbers of anglers were maximised; there was matching funding from other sources; and where programs addressed a major research, compliance or management need in relation to recreational fisheries. This year, the community was invited to submit proposals for saltwater projects under the small grants program or as a more general project. Only programs via the small grants program were considered for freshwater projects. This was because it was not considered appropriate to invite submissions for more general projects given that the carry-over of existing programs from previous years will mean that the 2002/03 budget for the freshwater trust is likely to be fully expended.

A total of 18 applications were received for funding from the Saltwater Trust. A further 19 applications were received for funding under the small grants program.

Outcomes

NSW Fisheries presented a summary of the saltwater trust cashflow for 2002/03, for Council's information. The Council was informed that NSW Fisheries had successfully negotiated with Kmart to sell the licence. The Committee also requested that NSW Fisheries investigate the potential for Big W to sell the licence.

The Council was advised that at the 8th RFSTEC meeting on 13 February 2003, the Committee recommended that an additional \$20,000 for the Licence Research Database program in this financial year be supported from the Saltwater Trust. These funds will be used to maintain data entry for the remainder of this financial year and into the next financial year.

NSW Fisheries advised that the Expenditure Committee had approved the allocation of funds for a Recreational Fishing Trusts Executive Officer. It was acknowledged that the role and work performed by the Recreational Fishery Management team had increased considerably since the introduction of the recreational fishing licence. This position would oversee the Saltwater Expenditure Committee and the Advisory Council and provide the service delivery expected by the Committees and ensure transparent reporting. As well as supporting the committee the position would have responsibility for communicating the work of the committee to clubs and the broader community, and provide a conduit for anglers' views into the committee.

A brief update on the compulsory acquisition of 10 Botany Bay prawn trawl businesses was provided. It was noted that this process had been completed, including the review of all 10

matters by a Compensation Review Panel formed for that purpose. Ongoing claims for accelerated depreciation, retraining and relocation costs are being received and processed. Council was informed that funds of \$198,261 will be carried over into 2003/04. However, the total budget required for 2003/04 is \$102,550. A budget is provided in the attached progress report for this program (see Attachment 4). It was recommended that funds of \$91,521 be returned to the Saltwater Trust for allocation to other programs.

Council was informed that the Recreational Fishing Saltwater Trust Expenditure Committee considered all the applications received by NSW Fisheries on 22 May 2003 and the following recommendations were made:

Issue

Regional Services (compliance) update.

Background (NSW Fisheries)

A general overview of NSW Fisheries' current education and compliance programs related to recreational fishing will be provided.

Outcomes

Some recent compliance activities:

Easter weekend (licences, bag and size limits etc)

Saltwater (estuaries)

4193 anglers checked; 496 did not comply

89% compliance

Inland

3069 anglers checked; 133 did not comply

96% compliance

ANZAC long weekend

Offshore - boat based anglers were generally pleased to see Fisheries Officers checking offshore fishing activities.

The new Recreational Mobile Squad has conducted a number of patrols in Lake Macquarie and Botany Bay. Squad members are currently being kitted out in Recreational Fishing Trust shirts, hats etc to recognise the source of funding and to clearly identify the squad.

An overview of some of the current offences/prosecutions was provided to members. For example:

- An angler was caught with a 123m mesh net in Botany Bay (RFH)
- A \$52,000 trawler was seized for illegally operating in the Clarence River.

12 trainee Fisheries Officers have been recruited recently (6 women, 6 men - 2 of these are indigenous officers)

The council would like to see a percentage of the fines from offenders go back into the Trust Funds if possible, especially if they are caught by the mobile squad. Money from offenders currently goes to Treasury, except if the judge awards moiety to NSW Fisheries.

Eastern freshwater cod operation – a helicopter and 4 vehicles were used to access remote areas eg Guy Fawkes National Park. The council discussed how people talk about this operation because a helicopter was used – no longer “safe” in remote areas.

The indigenous representative inquired about compliance issues relating to cultural events and education/training. Glenn provided the contact details for Roy Mills, Regional Manager – South, to discuss specific issues on the south coast.

Issue

Commercial fishing update.

Background (NSW Fisheries)

Ms Dianna Watkins, Principal Manager, Commercial, will provide an overview of current commercial fishing issues, including: Fishery Management Strategies; recent developments in key commercial fisheries - Estuary General, Estuary Prawn Trawl, Ocean Hauling, Ocean Trap and Line and Ocean Trawl fisheries; and the introduction of Category 2 Share Management.

Outcomes***Fishery Management Strategies***

- An FMS/EIS has been completed for Estuary General, Estuary Prawn Trawl and Ocean Haul fisheries and management responses are being implemented.
- Commencement of FMS/EIS for Ocean Trawl (fish and prawn trawl combined), Ocean Trap and Line, Lobster and Abalone (outsourced to a consultant at request of abalone industry). EISs are due for public exhibition in 2003.
- Management responses to be applicable to all fisheries including Codes of Conduct (develop or revise) and threatened species reporting.

Recent developments in key commercial fisheries***Estuary General***

The management responses identified in the FMS have been implemented. Regulation amendments (commenced 17 January 2003) have:

- Prohibited the use of spikes, clubs etc that harm fish when sorting catch.
- Prohibited discarding of cooked (riddled) prawns.
- Prohibited the use of hauling nets over strapweed seagrass beds.
- Reduced the maximum allowable length of General Purpose hauling nets to 500m (previously allowed to use up to 1000m nets in some estuaries) and use of the net is limited to 1 shot per day.
- Species that can be taken in the estuary general fishery are now specified.
- Implemented zoning scheme and confirmed which estuaries are open to commercial fishing in each zone.

A freeze on new nominations in the Estuary General fishery was introduced on 31 January 2003 to control effort, other than for deceased estates, short term illness and partnerships/companies.

Estuary Prawn Trawl

The management responses identified in the FMS have been implemented. Regulation amendments (commenced 17 January 2003) have:

- Prohibited the use of spikes, clubs etc that harm fish when sorting catch.
- Prohibited discarding of cooked (riddled) prawns.
- Prohibited trawling over seagrass beds (*Zostera* and *Posidonia*).
- Prohibited trawling in all EPT estuaries (Port Jackson, Hawkesbury, Hunter and Clarence Rivers) on weekends and public holidays.

It is now mandatory for by-catch reduction devices (BRDs) to be used in all estuaries (including the Hawkesbury) other than in the lower Hawkesbury (Broken Bay), where squid are targeted on weekdays (sunrise to sunset) – any prawns taken are to be released alive.

Ocean Hauling

The management responses identified in the FMS have been implemented. Regulation amendments (commenced 17 January 2003) have:

- Prohibited the use of general purpose hauling nets over strapweed seagrass beds.
- Prohibited the taking of garfish on weekends (midnight Friday to midnight Sunday) and public holidays (midnight to midnight).
- Implemented new zoning rules for garfish fishers (removed multi-zone access).
- Restricted hauling within 200m of certain beaches (over 50 NSW beaches now closed to ocean hauling activities).
- Restricted the use of the general purpose hauling net so that it must be deployed from, and hauled to, a beach.

Major tasks for 2003:

- Develop and implement a policy to manage the harvest of bait for the Commonwealth Tuna fishery in NSW waters.
- Develop a garfish recovery plan.

Ocean Trap and Line

- Operators who use a lift net to take bait to target tuna in state waters, now require a permit to use the lift net for this purpose. Bait caught by use of a lift net can only be used for targeting tuna. The taking of bait is an issue for both commercial and recreational fishers, and that a collaborative approach is needed across fisheries and jurisdictions.
- Mapping of fishing grounds is considered a priority by industry and will be part of the FMS implementation (with industry assistance).
- Gemfish have been nominated for listing as endangered under the *Environment Protection and Biodiversity Conservation Act 1999*. The public comment period has now closed and the Threatened Species Scientific Committee will consider the nomination.
- Environment Australia has recently released a discussion paper on protection of grey nurse sharks at the Cod Grounds site (near Laurieton).
- Negotiations between NSW Fisheries and AFMA regarding jurisdictional arrangements for tuna and tuna like species under the Offshore Constitutional Settlement arrangements are continuing. Industry are supporting NSW Fisheries in retaining management for tuna and tuna like species in waters inside 3nm. The Commonwealth is considering removing size restrictions on vessels in the Eastern Tuna and Billfish fishery.

Ocean Trawl

- Development of a trawl whiting fishery is being considered under FMS. This is an attempt to minimise the impact that ongoing improvement of BRDs in prawn trawl nets would have on the catch rates for red spot and stout whiting. Whiting consultation paper to be drafted.
- The Angourie Point juvenile king prawn closure has been renewed for a further 12 months until 1 March 2004. Consultation will take place with local fishers on opening part of the closure for the taking of school prawns should a flood occur.
- NSW Fisheries is collating and considering industry's responses to the OCS consultation paper on jurisdiction for Fish Trawling south of Barrenjoey Headland. Proposed transfer to Commonwealth with closed areas within 3nm.
- A recovery plan for silver trevally will be developed as a part of the Ocean Trawl FMS. A minimum legal length of 30cm (total length) has been suggested. A review of bag and size limits is to be addressed in the Recreational and Charter FMS.

Category 2 Share Management

- The six main restricted fisheries were included in Schedule 1 of the Fisheries Management Act as category 2 share management fisheries in March 2001.
- Two industry consultation papers were distributed seeking industry views on options for eligibility of category 2 shares.
- Shares will be the primary tool to manage effort levels and restructure at the fishery and/or endorsement level.
- Submissions to these papers indicate a majority support for an equal allocation of shares or a combination of equal allocation and additional shares based on Validated Catch History (VCH), with preservation of VCH for possible use at a later date if required.
- NSW Fisheries is considering industry's responses to the most recent consultation paper on share allocation criteria and undertaking preparatory work to allocate shares.

Website – Commercial Fisheries

New updated commercial fishery home pages are being progressively placed on the NSW Fisheries website.

Members are encouraged to read the commercial fishing fisheries management strategies as they are produced and be directly involved in the consultation process. Strategy and overview papers will be available as produced.

The commercial fishing sector continue to express concern regarding the use of spider wire and electronic winches by recreational fishers.

One member confirmed that ocean beach closures have been introduced for ocean hauling activities, based on previous Regional Liaison Committee work.

It was also mentioned that there is currently a freeze on the issue of permits for Commonwealth tuna operators to catch bait for own use from state waters. There are also greater restrictions on the use of lift nets for bait collection by commercial fishers.

For information.

Issue

Renewal of the Wonboyn River closure due to expire on 1 October 2003.

Background (NSW Fisheries)

The closure was first implemented in 1963 to allow the targeting of prawns and Australian salmon, while protecting all other fish species. In 1978 the closure was amended to prohibit the net used to capture Australian salmon.

The closure currently prohibits the use of all nets except the dip or scoop net, the push or scissor net, the hand hauled prawn net and the landing net from the whole of the waters of the Wonboyn River. A copy of the current closure is attached.

A Recreational Fishing Haven was implemented at Wonboyn Lake, River and Beach on 1 May 2002, therefore prohibiting commercial fishing in Wonboyn Lake.

The Eden fisheries office supports the renewal of the closure and state that they have not received any complaints about the closure and that it has been successful in protecting fish stocks and providing good recreational fishing opportunities.

Outcomes

Witches hats are not allowed to be used in this area – it was mentioned that if they were able to be used then this could form a standard closure throughout RFHs.

It was confirmed that public debate should occur on the issue of standardised closures in RFHs during the development of the recreational FMS.

Recommendation

The council recommends the renewal of this closure, as outlined, for a period of five years.

Renewal of the Wapengo Lake closure due to expire on 27 August 2003.

Background

The closure was first implemented in 1940 to allow free movement of fish to and from the Lake and to prevent the breaking up of shoals of salmon before they reached the Lake. In 1978 the closure was amended to permit the use of the dip or scoop net as the Lake contains some areas of shallow sand flats where the use of these nets by recreational fishers would not contravene the intention of the closure. In 1998 the closure was amended to permit the use of the landing net.

The closure currently prohibits the use of all nets except the dip or scoop net and the landing net from the whole of the waters of Wapengo Lake, therefore prohibiting all commercial fishing from the Lake. A copy of the current closure is attached.

The reference points of the closure - Oyster Farm No. 57-122 and Oyster Farm No. 69-332 - have been checked by the Eden fisheries office and are both still current.

The Eden fisheries office supports the renewal of the closure and state they have not received any complaints relating to the closure and that it has been successful in protecting fish stocks.

Issue

Renewal of the General Trout closure due to expire on 28 September 2003.

Background

Closures have existed in trout waters dating back to the mid 1900s to protect Atlantic salmon and trout species during the spawning season.

The general trout closure (a copy of the current closure is attached) currently provides for bag and size limits for the fish species Atlantic salmon, brook trout, brown trout and rainbow trout, specified areas for catch and release as well as open and closed seasons for salmon and trout. The open season is from the Saturday of the October long weekend to the Monday of the June long weekend, inclusive. The closure is for the remainder of the year and covers all trout waters, Statewide and also outlines the methods of fishing permitted.

The closure also provides for a possession limit of 200 freshwater yabbies, at any time during the year from the waters of Lake Jindabyne and Lake Eucumbene.

An additional closure for the Thredbo and Eucumbene Rivers also exists which effectively starts the closed season for these rivers on 1 May of each year (closure attached, for information).

The general trout closure and other inland closures will undergo review/consultation during the Regulation Review and the development of the Fishery Management Strategy for recreational fishing.

The local Fisheries office supports the renewal of the closure and state that they have not received any complaints about the closure and that it has been successful in protecting fish stocks and providing good recreational fishing opportunities.

Outcomes

This is a major closure that will be thoroughly considered during the development of the FMS/EIS for fish stocking.

It was highlighted that some Powerbait products can be used in motion. Fisheries Officers will use their discretion.

It was confirmed that Section 8 closures can be amended at any time (not restricted to FMS deliberations).

Recommendation

FISHERIES MANAGEMENT ACT 1994
Section 11 and Section 8 Notification – General Trout Closure

I, Edward Obeid, revoke the Notification titled General Trout Closure, published in NSW Government Gazette **No. 127 of 29 September 2000**, and all amendments thereto, which prohibited the taking of all species of fish from the waters specified in Schedules A-F of that Notification, except as specified under those Schedules. This revocation is effective from 29 September 2001.

I do now, by this Notification, prohibit the taking of all species of fish from the waters specified in Schedules A-G from 29 September 2001 for a period of two years, inclusive, except that as specified under the Schedules, the methods of fishing may be used to take the bag limit and possession limit of trout, salmon and other fish, during the open season described, from those waters listed.

For the purposes of this Notification the following conditions apply:

- (1) A rod is deemed to be attended if it is within ten (10) metres and in the sight of the person in possession of that rod.
- (2) An artificial lure or artificial fly, whether fitted with one or more hooks, is deemed to be a single hook
- (3) A person must not be in possession of more than one rod and line with hooks attached, in on or adjacent to any of the waters included in Schedules A, B and C of this Notification.
- (4) A person must not be in possession of any rod and line with hooks other than artificial flies or artificial lures attached, in on or adjacent to the waters included in Schedules A and B of this Notification.
- (5) A person must not be in possession of more than two rods and line with hooks attached, in on or adjacent to any of the waters included in Schedules D, E and F of this Notification.
- (6) A person must not be in possession of more than five hoop or lift nets, in on or adjacent to any of the waters included in Schedule G of this Notification. Schedule G of this Notification is an exception to Schedule F of this Notification.

Section 8 Notification - Fishing Closure
Thredbo and Eucumbene Rivers
Spawning Closure

I, Ian Macdonald, prohibit the taking of fish by the methods of fishing described in Column 1 of schedules A and B of this notification, from the waters described in Column 2, during the period specified in Column 3, respectively, of those schedules.

Fishing will be further subject to the 'conditions' as set out by this Notification.

This prohibition is effective until 2005 inclusive.

- (1) For the purposes of this Notification:
 - (i) A rod is deemed to be attended if it is within ten (10) metres and in the sight of the person in possession of that rod.
 - (ii) An artificial lure or artificial fly, whether fitted with one or more hooks, is deemed to be a single hook.
- (2) No person must be in possession of any rod and line with hooks other than artificial flies or artificial lures attached in on or adjacent to the waters permitting fishing activity in Schedules A and B of this Notification.
- (3) No person must be in possession of more than one rod and line with hooks attached, in on or adjacent to any of the waters permitting fishing activity in Schedules A and B of this Notification.

Other Business

Expression of Interest for Advisory Council on Recreational Fishing positions

The terms of five ACoRF members expire in August 2003. An Expression of Interest for these positions was advertised in the Sydney Morning Herald on Saturday 26 April 2003. Members whose terms are expiring have received an information package in the mail. These members are eligible for re-appointment and are encouraged to submit an expression of interest for their position. Applications close on Friday 20 June 2003. A table outlining the terms of ACoRF members is attached for information – members whose terms expire in August are marked in grey.

For information – existing members are encouraged to re-apply.

Out of session issue

The Blowering Dam closure relating to Murray Crayfish was supported by Council out of session and commenced on 1 May 2003. A copy of this closure was recently sent to members for information.

NSW Fisheries appreciates the council's consideration of this issue in such a short time frame. This has been a well received closure and there has been good compliance.

Correspondence received

- Mr John "Stinker" Clarke – proposal to increase the minimum size limit for blue swimmer crabs

Mr Clarke has been advised that an increase of the minimum size limit for blue swimmer crabs will be considered as part of the review of bag and size limits for recreational species, as part of the development of a fishery management strategy for recreational and charter fishing.

Noted – to be considered in the FMS.

- Mr Wayne Perry – Concern regarding the spearing of stingrays in Little Lake, Warilla

Mr Perry has expressed concern regarding the spearing of stingrays in Little Lake, which was outlined in an article in the Lake Times (Shellharbour) of 12 March 2003. A copy of this article will be distributed at the meeting for the council's consideration.

It was confirmed that a number of complaints have been received by NSW Fisheries about these activities. The council discussed whether this issue should be covered by local closures or a statewide closure.

Motion: That NSW Fisheries consider the introduction of a statewide regulation, to prohibit the needless killing of rays, during development of the FMS.

- Mrs Betty Thatcher – Request for a spearfishing closure at Shelly Beach reef, near Tathra

Mrs Betty Thatcher wrote to the Minister in response to information sent to her on the protection of Black Cod and the Grey Nurse Shark. Mrs Thatcher enclosed copies of previous correspondence she received from the former Minister for Fisheries, the Hon Bob Martin, MP as well as correspondence from the Mayor of Bega Valley Shire Council and letters she had sent to the local Fisheries Officer. Mrs Thatcher indicates that she has local

area support for the proposed closure and requests NSW Fisheries' action to protect Shelly Beach reef, near Tathra.

Advice from the local fisheries officer is being sought to investigate the potential for a spearfishing closure over the reef and also to determine how many spearfishers would be affected by a closure.

Mrs Thatcher has been advised that the Advisory Council on Recreational Fishing will consider the issues she has raised. A copy of this correspondence will be distributed at the meeting.

The council confirmed that this issue will be covered by the previous proposal to give qualified protection to rays throughout the state.

Action item: Write to Mrs Thatcher to advise the council has recommended that NSW Fisheries consider the introduction of a statewide regulation, to prohibit the needless killing of rays, during development of the Fisheries Management Strategy for recreational and charter fishing.

- Mr John Gallagher – Burns Point ferry closure

Proposal by Mr John Gallagher for a fishing closure at the southern Burns Point ferry approach ramp on the Richmond River, northern NSW.

Mr Gallagher met with the Director, Mr Steve Dunn, on Wednesday 5 February 2003 to outline his proposal for a closure to all fishing within a 100 metre radius of the southern Burns Point ferry approach ramp. Mr Gallagher has established an informal fish-feeding program in this area, which forms part of the existing Richmond River recreational fishing haven.

Mr Gallagher advises that this activity has become a valuable tourist attraction, promoting the region's quality angling opportunities and an educational experience for local primary and high school children.

Letters supporting Mr Gallagher's proposed fishing closure have been received from the Ballina Fishermen's Co-op, the Ballina Marine Discovery and Resource Centre, the Ballina Visitor Information Centre, and Sustainable Fishing and Tourism Incorporated.

The council was concerned that this proposal would result in recreational fishers being excluded from a Recreational Fishing Haven that was bought with recreational licence funds.

The council understands the intent of Mr Gallagher's proposal, however, it was stated that the majority of estuaries have informal "fish feeding programs". The council was concerned that support for this proposal would set a precedent with flow-on effects in many other estuaries. It was suggested that Mr Gallagher try to get the area recognised as a formal fish feeding area by the Ballina Council.

The advisory council does not support an exclusion zone for an "informal" feeding area.

Action item: Write to Mr Gallagher to explain that this proposal would set an open ended precedent for anyone to close areas where people feed fish. Mr Gallagher should be encouraged to get the area recognised as a formal fish feeding location by the Ballina Council.

- Woronora River Life Saving and River Patrol Club
The council does not support a closure to bait gathering in the area.

Action item: Write to the Woronora River Life Saving and River Patrol Club to advise that the council does not support a closure to bait gathering in the area.

- Ms Judith Snellenburg - Shelly Beach Lagoon
The council confirmed that this issue will be covered by the previous proposal to give qualified protection to rays throughout the state.

Action item: Write to Mrs Snellenburg to advise the council has recommended that NSW Fisheries consider the introduction of a statewide regulation, to prohibit the needless killing of rays, during development of the Fisheries Management Strategy for recreational and charter fishing.

Around the table

- A species of trevally caught around Lord Howe Island is classified as silver trevally, however, it grows up to 30 pounds. It was suggested that research should be conducted on this species.
- It was mentioned that there is still uncertainty about the distribution and numbers of grey nurse sharks.
- Striped marlin – Council believes the resource would be worth more as a recreational only species – economic survey is progressing.
- Indigenous Fishing Strategy and Communication strategy.

Action item: Request Tom Smith's attendance at the next meeting to discuss the IFS and related issues.

- A breakdown of NSW Fisheries positions funded by the Recreational Fishing Trusts was requested.

Action item: NSW Fisheries to provide the Council with information on Trust funded positions at the next meeting.

- Recreational fishing access – a proposal has been sent to the Sydney Catchment Authority requesting minimal fishing access to Prospect Reservoir. The SCA has advised that a risk assessment should be conducted for the activity.
- Impoundment access – a freshwater fishing publication, similar to the QLD publication previously distributed to Council members, is being progressed.
- Rock fishing safety – The Bureau of Meteorology's Marine Weather Committee and NSW Fisheries are working together to reinforce warnings about rock fishing safety issues.
